Update from the State Capitol

The 85th legislative session began Jan. 10 and TETAF staff have been busy at the Capitol advocating on behalf of the trauma and emergency healthcare system.

As of Feb. 6, more than 1500 House bills and almost 750 Senate bills had been filed. The deadline to file legislation is March 10. Of note, 4 bills ([HB 67](#), [HB 275](#), [SB 90](#), [SB 661](#)) have been filed to eliminate the Driver Responsibility Program without providing a replacement sources of funds. In addition, Senator Kirk Watson (D-Austin) has filed [SB 266](#), which would cut the fees associated with the Driver Responsibility Program in half, but allocate 100% of the funds to the trauma system. Several other bills have been filed to update or alter the program in some way.

Rep. Sarah Davis (R-Houston) has filed [HB 1148](#), calling for the creation of eight administrative hubs to provide administrative functions for the RACs. It also sets the groundwork for the creation of a 25-year written plan for coordinating emergency medical services throughout the state. TETAF is working with Rep. Davis to advocate for all 22 RACs and share the opinions expressed on this bill, both positive and negative.

The Lieutenant Governor has officially named Senate Committees and the Senate Appropriations Committee has been meeting regularly to begin work on the state budget.

Dr. Jeff Beeson, DO, traveled to Austin on Jan. 31 to testify to the needs of the state trauma and emergency healthcare system. He highlighted the overall need for continued funds for a growing state population, focusing on the EMS and Trauma Care Tobacco Endowment Fund 5046 and the Designated Trauma Facility and EMS Account 5111. Dr. Beeson also detailed the important work of the RACs, stressing the need for a specific appropriation to continue services and cover the growing responsibilities placed upon them.

Over the last several budget cycles, the Department of State Health Services has allocated general revenue (GR) dollars to try and maintain funding lost from the tobacco account (5046). These funds are included in the current Senate budget proposal at \$1.4 million per year. However, even with the DSHS GR funds being made available, funding to RACs and EMS will be cut by approximately \$1.4 million per year if no action is taken. The initial Senate budget also recommends more than \$165 million per year in appropriations from Account 5111. The legislature must balance the various needs funded by this account and ensure that hospitals, EMS and RACs remain the focus of this funding.

There will be numerous opportunities for stakeholders to testify at future hearings, once subcommittees are named. For now, TETAF encourages all stakeholders to reach out to their [State Senator](#), especially those on the [Finance Committee](#), to encourage them to fully fund the needs of the trauma and emergency healthcare system. Calls and emails from constituents are crucial to impacting the budget process.

[House committees](#) were named on Feb. 9. Of note, Rep. John Zerwas, MD (R-Richmond) will serve as Chair of the Appropriations Committee and Rep. Oscar Longoria (D-Mission) will serve as Vice Chair. Both are familiar with the needs of the trauma system. In fact, Rep. Longoria last session sponsored the rider to provide additional funding to the RACs. Rep. Four Price (R-Amarillo) will serve as Chair of the House Public Health Committee and Rep. J.D. Sheffield, MD (R-Gatesville) will serve as Vice Chair. Both Rep. Price and Rep. Sheffield are also very familiar with the needs of the trauma system, having served last session on the Appropriations Health & Human Services subcommittee.

Be on the lookout for increased updates from TETAF as the committees now begin meeting to consider bills filed. TETAF provides a [VoterVoice](#) advocacy tool online and encourages all stakeholders to use that resource to contact their local lawmakers.

Save-the-Date: TETAF Hospital Data Management Course

This course has been developed for direct training for immediate responders (lay personnel) and professional first responders in external hemorrhage control in response to a call from the Hartford Consensus for direct training.

Texas Perinatal Services Update

The TETAF Perinatal Services Program is underway, having conducted several surveys and continuing to tweak the process to provide facilities with the very best service available.

Prior to the survey, facilities will receive a Pre-Survey Questionnaire (PSQ). The PSQ is an information gathering tool to provide the surveyors with advance knowledge of the program. All programs are unique and it is helpful for the surveyors to understand how individual programs works in order to plan

for the site survey.

If your facility is not able to answer a question in the PSQ, please share what you can and select N/A if needed. If TETAF requires additional information to address the rule criteria, a surveyor will ask for it on site. The PSQ is confidential and is not shared with anyone other than the facility's surveyors and the TETAF survey coordinators.

State EMS Rules Adopted, Become Law Feb. 12

The adopted EMS rules were posted in the Feb. 3 issue of the *Texas Register*. They will become law on Feb. 12, 2017. The draft rules were shared with stakeholders and updated extensively throughout the process. The GETAC EMS Committee also traveled the state to ensure that all stakeholders were given the opportunity to provide input.

The DSHS FY 2017 Uncompensated Trauma Care (UCC) application deadline has been extended until Feb. 28, 2017. An updated application is available [online](#).

In regard to the reporting in the last quarter of Calendar Year (CY) 2015, DSHS is also asking facilities to convert one of the ICD-10 codes to a qualifying ICD-9 codes that meets the inclusion criteria, if possible.
